



# Seven Mile Walk with Jesus Pilgrim Application

## Part 1: SPONSOR REMINDERS

### AND INSTRUCTIONS v. 5-25

The purpose of Seven Mile Walk with Jesus (7MWWJ) is to:

- Strengthen a Pilgrim's relationship with our Lord Jesus Christ
- Encourage and equip church members for leadership roles within their church
- Conduct activities to inspire and challenge Christian action in homes, churches, places of work, and communities.

*The role of sponsorship is not a light one; give it your prayerful consideration. 7MWWJ is not for everyone. Sponsors should be discerning in their sponsorship.*

#### **Sponsorship Checklist:**

Pilgrim should:

- Attend church regularly
- Have an active desire to deepen their faith and become closer to Jesus Christ
- Pay \$50 deposit, attached to the Pilgrim application

Sponsor Responsibilities:

- Pray, Pray, Pray
- Make a check payable to 7MWWJ in the amount of \$250 at or before Sponsor's Hour
- Stay in constant contact with Pilgrim prior to weekend
- Confirm accommodation needs (dietary, medical, or physical)
- Transportation to and from Weekend
- Collect Palanca from Community plus friends and family of the Pilgrim
- Make Placemats (currently 5 personalized placements)
- Provide Snacks
- Attend Sponsor's Hour, Mañanitas and Closing
- Bring Pilgrim to Reunion Gathering
- Help Pilgrim find a small group

**Due to the huge responsibility of a sponsor,** the maximum number of pilgrims a single person can sponsor per weekend is one. A group or church may choose to sponsor a pilgrim to share the responsibilities but must designate an individual in the group who is responsible to ensure that all sponsorship requirements are met

Sponsors should also make their pilgrims aware of the fact that **we are a diverse and ecumenical community.** There may be differences in doctrinal beliefs among the pilgrims and team. However, our focus is to remain centered on Christ and to avoid any activities that will distract us from doing so. **Team members and pilgrims alike will not promote a personal agenda on political or social issues or other divisive, controversial topics during the teaming process or on a weekend.**
